

Air Academy Credit Union
“America 250: Colorado Destination Giveaway”
Official Rules

1. NO PURCHASE OR TRANSACTION IS NECESSARY TO ENTER OR WIN THE “America 250: Colorado Destination Giveaway.” VOID WHERE PROHIBITED.
2. Sponsor: Air Academy Federal Credit Union, DBA Air Academy Credit Union (“AACU”) is a sponsor of the giveaway. The address for AACU is 9810 N. Union Blvd, Colorado Springs, CO 80924.
3. **Giveaway Period/Description:** America 250: Colorado Destination Giveaway (the “Giveaway”) begins on 6/24/2026, at 8 a.m. Mountain Time (“MT”) and ends on 8/1/2026, at 5:00 p.m. Mountain Time (“MT”). There will be One (1) GRAND PRIZE winner AND Eight (8) PRIZE PACK winners by a random drawing from all eligible entries during the “Qualification Period,”.

Qualification Period:

6/24/2026 to 8/1/2026

4. **Eligibility:** Giveaway is open to eligible Giveaway participants (“Entrants”). Eligible Entrants are legal residents of the 50 United States or the District of Columbia, 18 years of age or older (or applicable age of majority based on entrant’s resident state, void where prohibited). AACU employees, officials, and their immediate family members are not eligible to participate in the Giveaway. The Giveaway is void where prohibited or restricted by law. Participation constitutes Entrant’s full and unconditional agreement to these Official Rules and decisions made by AACU, which are final and binding in all matters related to the Giveaway. Winning a Prize is contingent upon fulfilling all requirements set forth herein. Alternate entry forms are limited to one per member and will be entered into the drawing as received but must be received by 8/1/2026, at 5:00 p.m. Mountain Time (“MT”) to be placed into the Drawing. Postmark date will not determine entry into Drawing.
5. **How to Enter: NO PURCHASE OR TRANSACTION IS NECESSARY TO ENTER OR WIN.** All Giveaway entries have an equal chance of winning. There are two ways to enter the Giveaway: **(1)** Fill out an entry form using the link on aacu.com/ between 6/24/2026 - 8/1/2026 **(2)** Submit an alternate entry form with a limit of one entry form per member. Entrants are limited to one entry per alternate entry form per day regardless of entry method. Entrants who would like to participate using the alternate entry method will receive one (1) entry by printing your full name, address (no P.O. Box accepted), city, state, zip code, email address, phone number and date of birth on a plain piece of 3" x 5" paper and mail it in a stamped, hand-addressed business-size envelope to: Air Academy Credit Union, RE: America 250: Colorado Destination Giveaway, P.O. Such mail-in entries will be entered into the drawing as received but must be received by 8/1/2026, at 5:00 p.m. Mountain Time (“MT”) to be placed into the Drawing. There is a limit of one entry per outer mailing envelope. AACU shall not be responsible for illegible, damaged, lost, late, stolen, postage-due, incomplete, undelivered/undeliverable, misdirected or returned mail, regardless of cause. By mailing in an entry form, you agree to the terms and Official Rules for this Drawing, and to the decisions made by AACU. You further agree that there is no appeal or way to object to the decisions, opinions or determinations of AACU. All entries become the property of AACU and will not be acknowledged or returned.

- 6. Prize:** After the Qualification Period (see Qualification Period listed in item #3) of the Giveaway has closed, but at the latest by approximately 8/3/2026, AACU will randomly select One (1) Grand Prize Winner from the eligible Entrant pool and Eight (8) Prize Pack Winners. Winners will be notified by phone. The potential winner will be notified by phone at the phone number provided during registration. THE SPONSOR WILL CALL EACH POTENTIAL WINNER THREE (3) TIMES WITHIN ONE (1) HOUR. SAID POTENTIAL WINNER MUST ANSWER ONE OF THE CALLS. IF THE POTENTIAL WINNER DOES NOT PICK UP ONE OF THE CALLS WITHIN THAT HOUR, THE POTENTIAL WINNER WILL BE DISQUALIFIED AND SPONSOR WILL RANDOMLY SELECT THE NEXT POTENTIAL WINNER, WHO WILL ALSO BE NOTIFIED IN THE SAME METHOD ON THE SAME DAY. Sponsor is not obligated to and will not leave a voicemail or other message when contacting the potential winner. Notification is deemed to have occurred immediately upon placing of a phone call. The Sponsor is not responsible for any change of email address, mailing address, and/or telephone number of Entrants. The Giveaway Sponsor is not responsible for and shall not be liable for late, misdirected or unsuccessful efforts to notify a finalist and/or potential winner(s). If the potential winner does not claim the Prize within the appropriate time given upon, the Entrant will automatically be disqualified, and their Prize will be forfeited.

The first name and first initial of last name (example – Jane D.) for each Winner will be posted on AACU.com and AACU social media channels.

If an alternate entry form is drawn, but judges are unable to determine the Winner because of illegible writing, that entry form will be disqualified. No copies or mechanical reproductions accepted. Once submitted, entries become the sole property of AACU and will not be acknowledged or returned. See "Odds of Winning" section for the information regarding your odds of winning.

- 7. Liability/General Rules:** By entering the Giveaway, each Entrant agrees that he/she has read these Official Rules and that they will strictly bind he/she. AACU is not responsible for any loss that may occur in connection with the Giveaway. Entrant agrees to hold AACU harmless from any liability arising from the participation in the Giveaway or the acceptance, receipt, possession, or misuse of the prize. AACU and each of its employees, officials, directors, members, and representatives and agents are not responsible for any negligence, claims, liability, injury, property loss, or other damages of the Entrants and/or misuse of prizes awarded or participation in the Giveaway. AACU is not responsible for incorrect or inaccurate information, whether caused by tampering, hacking, or by any of the equipment or programming associated with the Giveaway. AACU reserves the right to cancel, suspend and/or modify the Giveaway, or any part of it, if any fraud, technical failures, viruses, tampering, or any other factor beyond AACU reasonable control impairs the integrity or proper functioning of the Giveaway, as determined by AACU in its sole discretion. In such event, AACU reserves the right to award all prizes at random from among the eligible entries received up to the time of the impairment. AACU reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Giveaway or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. The failure of AACU to enforce any term of these Official Rules shall not constitute a waiver of that provision.

No more than the stated number of prizes will be awarded. Prizes cannot be substituted, assigned or transferred by Winners. AACU reserves the right to substitute a prize of equal or greater value should the featured prize become unavailable for any reason. AACU reserves the right to disqualify Entrants who fail to follow these Official Rules and regulations, or who make any misrepresentations relative to the Giveaway and redemption of prize.

- 8. Winner Notification and Prize Redemption:** Winners will be notified by phone and/or email after the Qualification Period closes, but no later than 5:00 p.m. (MST) August 3, 2026. Winners will be contacted for arrangements to receive either the Grand Prize or Prize Pack. Potential Giveaway winner(s) are subject to verification, including verification of eligibility. If an Entrant is unable to verify his/her information, the Entrant will automatically be disqualified and their Prize, if any, will be forfeited. AACU reserves the right to determine an alternate winner in accordance with these Official Rules if any winner is disqualified, cannot be contacted, is deemed ineligible for any reason, or is not available to participate in any applicable Giveaway events.
- 9. Publicity Authorization:** Winners agree to allow AACU to use his/her name in promotional and other credit union materials without additional compensation or permission, except where prohibited by law. To protect the Winner's privacy, only the Winner's first name and first letter of the last name will be used in promotional or publicity communications (examples – Jane D., John H.).

Winners will be given the opportunity to disclaim the prize before their first name and first initial of their last name is displayed on social media and AACU.com.

- 10. Privacy:** Any personally identifiable information collected during your participation in this Giveaway will be collected by AACU and used by it and its agents for purposes of the proper administration and fulfillment of the Giveaway as described in these Official Rules, for any additional opt-in information you agreed to upon participation, and in accordance with AACU Privacy Policy, posted at <https://www.AACU.com> and as allowed by law.
- 11. Tax Details:** Value of the Grand Prize is approximately \$1,200.00. Value of the Prize Pack is approximately \$225.00. Value of the selected prize(s) will be disclosed to Prize Winner when Winner is selected. AACU will report all prize winnings to the appropriate agencies as required by applicable law. Winners are responsible for all tax consequences (if any) of the prizes and will be required to furnish a taxpayer identification number prior to claiming any prize.
- 12. Arbitration:** Except where prohibited by law, as a condition of participation in this Giveaway, Entrant agrees that (1) any disputes and causes of action arising out of or connected with this Giveaway and or any prizes awarded, shall be resolved individually, without resorting to any form of class action, and exclusively, by final and binding arbitration under the rules of the American Arbitration Association ("AAA") and shall be held at the AAA regional office nearest the participant; (2) the Federal Arbitration Act shall govern the interpretation, enforcement, and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights, claims, punitive, incidental, or consequential damages, or any other damages, including attorney's fees, other than Entrants actual out-of-pocket expenses (i.e., cost associated with entering the Giveaway), and Entrant further waives all rights to have damages multiplied or increased.

13. Odds of Winning: The odds of winning the Prize depend on the number of eligible entries received. Based on AACU estimate of eligible Entrants during the Qualification Period, odds of winning each prize are 1 in 4000.

14. Choice of Law: All issues and questions concerning the construction, validity, interpretation, and enforcement of these Official Rules, or the rights and obligations of Entrant and AACU in connection with the Giveaway, shall be governed by, and construed in accordance with, the substantive laws of the State of Colorado without regard to choice of law rules.

Consumer Disclosure: Each Entrant hereby agrees to release, indemnify, and hold harmless AACU, and other individuals or entities involved in the administration, development, fulfillment, and execution of the Giveaway and all their immediate family members (spouse, parent, child, sibling, in-law and/or the household members of each). The Giveaway is intended solely for viewing and participation in the United States and shall be construed and evaluated solely under United States federal, state, and local laws. The Giveaway is void where prohibited or restricted by law. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and the decision of AACU, which are final and binding in all matters related to the Giveaway. Winning a prize is contingent upon fulfilling all requirements set forth herein (see "Eligibility" section for the definition of an eligible Entrant).
